### SECTION I: INSTRUCTIONS TO BIDDERS

### 1. Rights of Public Entity

The Oshikoto Regional Council reserves the right:

- (a) to split the contract as per the lowest evaluated cost per item, or
- (b) to accept or reject any quotation; and
- (c) to cancel the quotation process and reject all quotations at any time prior to contract award.

### 2. Preparation of Quotations

You are requested to quote for the items mentioned in Section III by completing, signing and returning:

- (a) The Quotation Letter in Section II with its annex for Bid Securing Declaration
- (b) The List of Goods and Price Schedule Section III;
- (c) The Specifications and Compliance Sheet in Section V; and
- (d) Any other attachment deemed appropriate.

You are advised to carefully read the complete Request for Sealed Quotations document, including the Special Conditions of Contract in Section VII, before preparing your quotation. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

### 3. Validity of Quotations

The Quotation validity period shall be 60 days from the date of submission deadline.

4. Eligibility Criteria: To be eligible to participate in this exercise, you should have:

7	Attach proof of confirmation of account from a Namibia banking Institute, issued within the past 6 months.
8	Each page should be initialled and the business principal should be in line.
9	Certified Copies of the Vehicle Registration documents be attached
10	In case of hire/rent a truck, a lease agreement between the owner of the truck and the person to rent a truck be attached/provided.

11. Trucks must be able to operate in <u>Rocky and Sandy Roads</u>, especially in Eengodi and Nehale Lya Mpingana Constituencies, in Oshikoto Region.

### **Bid Securing Declaration**

Bidders are required to subscribe to a Bid Securing Declaration for this procurement process. The Bidder shall furnish as part of its quotation, a Bid Security as per the format contained in Appendix to Quotation Letter of this document for an amount of NAD based on 2% of your budget estimate for the procurement validity period of bid security must be 30 days beyond the quotation validity period.

### 5. Delivery

<u>Delivery shall be 5 days after acceptance</u>. Deviation in delivery period shall be considered if such deviation is reasonable.

- 5.1. Test and Inspections will be conducted on the goods at delivery:
  - 6.1.1 Any defect on the truck/ roadworthiness.
  - 6.1.2 Specified capacity as per description.
  - 6.1.3 Operation disk availability
  - 6.1.4 Functionality of the truck
  - 6.1.5 Availability of all spare components
  - 6.1.6 Tyres and service history

### 6. Sealing and Marking of Quotations

Quotations should be sealed in a single envelope, clearly marked with the Procurement Reference Number, addressed to the Public Entity with the Bidder's name and contact information at the back of the envelope.

### 7. Submission of Quotations

Quotations should be deposited in the Quotation/Bid Box located at Oshikoto Regional Council Head Office, Penda Ya Ndakolo Street, on or before 04 June 2024 at 11H00. Quotations by post or hand delivered should reach the Secretary, Procurement Committee, P. O Box 19247, Omuthiya, by the same date and time latest. Late quotations will be rejected. Quotations received by e-mail will not be considered.

### 8. Opening of Quotations

Quotations will be opened internally by the Public Entity immediately after the closing time referred to in section 8 above. A record of the Quotation Opening stating the name of the bidders, the amount quoted, the presence or absence of a Bid Security will be available at Oshikoto Regional Council Head Office at Omuthiya.

### 9. Evaluation of Quotations

The Public Entity shall have the right to request for clarifications during evaluation. Offers that are substantially responsive shall be compared on the basis of evaluated cost, subject to Margin of Preference where applicable, to determine the lowest evaluated quotation.

### 10. Technical Compliance

Bidders shall submit along with their quotations documents, catalogues and any other literature to substantiate compliance with the required specifications and to qualify deviations if any with respect to Public Entity's requirements.

### 11. Prices and Currency of Payment

Prices shall be fixed in Namibian Dollars as quoted. Quotation shall cover all cost including duties.
