CANCELLATION OF BID

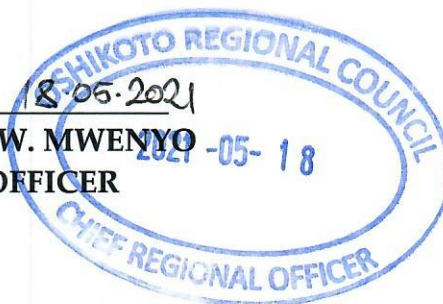
